Aerial Permit: Aerial 2017-1

This permit is issued for the calendar year 2017 under the following conditions:

1. All pesticide applications shall be made by certified commercial applicators.
2. The pilot/ ground crew shall possess a valid copy of the labeling for all products applied by air.
3. Pesticide applications shall be reported to the Vermont Agency of Agriculture, Food & Markets, weekly. The permitted shall submit written reports on forms furnished by the Secretary of Agriculture.
4. Pesticides shall be applied in accordance with Permit **VAAFM 2016-MLP-01** Or **VAAFM 2017-MLP-01** Larvicide permit.
5. The following list (**with the exceptions and conditions listed in item # 6**) indicates the pesticide products that are authorized by this permit. Application of these products can only be made according to and if allowed by label specifications.

All applications shall be made in accordance with rates and dilutions included in the permit application and specified by the original container label or supplemental labeling on or accompanying the product. All products shall be registered with the Vermont Agency of Agriculture, Food & Markets prior to use.

This permit does not allow for the application of pesticides from the air to treat rights-of-way, agricultural commodities or aquatic or nuisance pests other than those listed under the permit.
